



Natural Area Protection Tax Exemption Program (NAPTEP)



APPLICATION FORM AND GUIDE

The Natural Area Protection Tax Exemption Program (NAPTEP) is available to **Islands Trust Area landowners in the Capital, Comox Valley, Cowichan, Nanaimo, Powell River, and Sunshine Coast Regional Districts** in British Columbia. Landowners who permanently protect natural and cultural features of their land receive a 65% exemption in property taxes on the protected portion of their land. The application process is described below.

PHASE ONE

1. PLAN YOUR APPLICATION

Before making a decision to apply to NAPTEP, you should obtain independent legal and tax advice to be sure you understand how it will affect you.

To receive your tax exemption for the next tax year you **MUST** submit your application by April 1st at the latest. We strongly recommend that you submit your application early.

You may find it helpful to read the complete application package that can be downloaded from www.islandstrustfund.bc.ca or obtained from Islands Trust offices located in Victoria and on Gabriola and Salt Spring Islands. Other useful information sources are listed at the end of this document.

2. SUBMIT YOUR FEE & APPLICATION DOCUMENTS

If you decide to apply, you will need to submit an application and the information required on the application checklist. You will also need to submit the Phase One application fee of \$275, **payable to the Islands Trust**. Additional application packages can be downloaded from www.islandstrustfund.bc.ca/naptep.cfm or obtained from Islands Trust offices located in Victoria and on Gabriola and Salt Spring Islands. *Please note: Staff cannot process your application until a complete application is submitted and the Phase One fee has been received.*

3. STAFF REVIEW YOUR APPLICATION (UP TO 30 DAYS)

Once you have submitted a complete application, Islands Trust Fund staff will evaluate your application to confirm its eligibility under the *Natural Area Protection Tax Exemption Regulation*. This evaluation will include a visit to your property.

4. APPLICATION REVIEWED BY OTHER ORGANIZATIONS

Your application will be processed by the Trust Fund Board and forwarded to your Local Trust Committee and other appropriate organizations for information. Staff will prepare a staff report, including a recommendation on your application, for Trust Council for their consideration and approval. You may also want to request that your conservation covenant co-held by another conservation organization, for example, your local conservancy.

5. TRUST COUNCIL CONSIDERS YOUR APPLICATION

Trust Council meets quarterly and will make one of the following decisions about your application:

- Issue a Natural Area Exemption Certificate subject to registration of a NAPTEP covenant on your Certificate of Title
- Put your application on hold pending further information
- Decline your application

You will receive written notice of Trust Council's decision. If your application is approved, you will be advised of the steps for Phase Two of the application process. You will have **two years** to complete Phase Two, after which, you will need to resubmit your application if you wish to proceed.

PHASE TWO

6. PAY PHASE TWO FEE & CONSULT ISLANDS TRUST FUND STAFF

Once your application has been approved, you must submit the Phase Two fee of \$175, payable to the Islands Trust.

7. REVIEW NAPTEP COVENANT WITH A LAWYER

A draft of the covenant will be sent to you after payment for Phase Two has been received. It is recommended that you review this NAPTEP covenant with your lawyer and tax advisor.

8. OBTAIN A SURVEY THE COVENANT AREA

If you are only applying the NAPTEP covenant to a portion of your property, a registered British Columbia Land Surveyor will need to prepare a survey of the area. Depending on your situation, you may be able to submit an explanatory plan instead of a full survey. You will need to contact the Land Titles Office for more information on this option.

9. COMPLETE A BASELINE REPORT

The Baseline Report is a record of the condition of a covenant area at the time the covenant is registered. It typically includes information on the area's ecology and other significant features. You will need to hire a pre-approved Environmental Professional to prepare this report. Guidelines for the Environmental Professional to follow and a sample report are available at www.islandstrustfund.bc.ca/naptep.cfm.

10. HAVE COVENANT SIGNED BY ALL PARTIES

All parties must sign the covenant before it is registered.

11. REGISTER COVENANT WITH LAND TITLES OFFICE

Once all signatures are obtained, you must submit your covenant to the Land Titles Office to be registered on your Certificate of Title by October 1 to receive your property tax exemption for the following tax year.

12. NATURAL AREA EXEMPTION CERTIFICATE

After the covenant has been registered on your Certificate of Title, the Islands Trust will issue you a Natural Area Exemption Certificate. The Islands Trust Fund will forward this certificate to the Land Titles Office, BC Assessment, and your regional district for tax purposes.

13. MONITORING

To ensure that your land is protected forever, your NAPTEP covenant will be monitored every year. You (and future landowners) will receive a notice from the Islands Trust Fund each year reminding you that an Islands Trust Fund monitor will be visiting your property. Following the visit, the Islands Trust Fund will send you a letter advising you of your compliance with NAPTEP.

- Uses and approximate dimensions of existing buildings
- Approximate location of all driveways, trails, site access points and adjacent roads.
- Approximate location and description of all natural values and amenities proposed for protection
- Approximate location and dimensions of proposed covenant areas and easement areas (if required)
